1 The Court, having considered the motion of William J. Hoffman of
2 Trigild, Inc. ("Receiver"), the Court-appointed permanent receiver for Nationwide
3 Automated Systems, Inc. ("NASI"), Oasis Studio Rentals, LLC, Oasis Studio
4 Rentals #2, LLC, Oasis Studio Rentals #3, LLC, and their subsidiaries and affiliates
5 ("Receivership Entities") ("Receivership Entities"), for an order (A) Resolving
6 Disputed Claims and Approving Proposed Allowed Claim Amounts; (B) Approving
7 Proposed Distribution Plan; and (C) Authorizing Receiver to Make Interim
8 Distributions ("Motion"), and good cause appearing therefor, hereby orders as
9 follows:

10 1. The Motion is granted.

11 2. The Receiver's proposed allowed claim amounts, as listed on
12 Exhibits A and B to the Declaration of Aaron J. Kudla ("Kudla Decl."), are
13 approved as the full and complete lists of allowed investor and creditor claims,
14 respectively, against the receivership estate.

15 3. The Distribution Plan attached as Exhibit F to the Kudla Decl. is
16 approved;

17 4. The Receiver is authorized to make an initial round of interim
18 distributions totaling \$31.5 million; and

19 5. The Receiver, in his discretion, is authorized to make subsequent
20 rounds of interim distributions, with the consent of the Securities and Exchange
21 Commission.
