1 The Fourteenth Interim Fee Application of Allen Matkins Leck Gamble
2 Mallory & Natsis LLP, General Counsel to the Receiver, for Payment of Fees and
3 Reimbursement of Expenses ("Application") filed by Allen Matkins Leck Gamble
4 Mallory & Natsis LLP ("Allen Matkins"), general counsel to William Hoffman
5 ("Receiver"), Court-appointed permanent receiver for Defendant Nationwide
6 Automated Systems, Inc. ("NASI"), Relief Defendants Oasis Studio Rentals, LLC,
7 Oasis Studio Rentals #2, LLC, and Oasis Studio Rentals #3, LLC ("Relief
8 Defendants"), and their subsidiaries and affiliates (collectively "Receivership
9 Entities"), came on for hearing on August 20, 2018. Appearances were as noted on
10 the record.

11 The Court having received and read the Application, including any supporting
12 declarations and objections filed therein, and being so advised in the matter and
13 finding good cause, orders as follows:

14 **IT IS ORDERED** that the Application of Allen Matkins is granted.

15 **IT IS FURTHER ORDERED** that Allen Matkins' fees and costs for the
16 Fourteenth Application Period are allowed and approved, on an interim basis, in the
17 amounts of \$214,990.65 and \$25,513.01, respectively.

18 **IT IS FURTHER ORDERED** that the Receiver is authorized and directed to
19 pay Allen Matkins \$171,992.52 in fees and \$25,513.01 in costs from assets of the
20 receivership estate, which amounts reflect an interim payment of 80% of the
21 allowed fees and 100% of the allowed costs.
