4 Hoffman ("Receiver"), Court-appointed permanent receiver for Defendant
5 Nationwide Automated Systems, Inc. ("NASI"), Relief Defendants Oasis Studio

15 for the Application Period are allowed and approved, on a final basis, in the amounts
16 of \$9,157.50 and \$1,840.38, respectively.

17 **IT IS FURTHER ORDERED** that the Receiver is authorized and directed to
18 pay Damian & Valori, LLP \$9,157.50 in fees and \$1,840.38 in costs from assets of
19 the receivership estate.
