1 The First Interim Fee Application of McGrail & Bensinger LLP, Local
2 Counsel in New York to the Receiver, for Payment of Fees and Reimbursement of
3 Expenses ("Application") filed by McGrail & Bensinger LLP ("McGrail"), local
4 counsel in New York to William Hoffman ("Receiver"), Court-appointed permanent
5 receiver for Defendant Nationwide Automated Systems, Inc. ("NASI"), Relief
6 Defendants Oasis Studio Rentals, LLC, Oasis Studio Rentals #2, LLC, and Oasis
7 Studio Rentals #3, LLC ("Relief Defendants"), and their subsidiaries and affiliates
8 (collectively "Receivership Entities"), came on for hearing on August 20, 2018.
9 Appearances were as noted on the record.

10 The Court having received and read the Application, including any supporting
11 declarations and objections filed therein, and being so advised in the matter and
12 finding good cause, orders as follows:

13 **IT IS ORDERED** that the Application of McGrail is granted.

14 **IT IS FURTHER ORDERED** that McGrail's fees and costs for the First
15 Application Period are allowed and approved, on an interim basis, in the amounts of
16 \$29,177 and \$1,161.93, respectively.

17 **IT IS FURTHER ORDERED** that the Receiver is authorized and directed to
18 pay McGrail \$23,341.60 in fees and \$1,161.93 in costs from assets of the
19 receivership estate, which amounts reflect an interim payment of 80% of the
20 allowed fees and 100% of the allowed costs
