1 The Fourteenth Interim Fee Application of the Receiver, William Hoffman of
2 Trigild, Inc., ("Receiver"), the Court-appointed permanent receiver for Defendant
3 Nationwide Automated Systems, Inc. ("NASI"), Relief Defendants Oasis Studio
4 Rentals, LLC, Oasis Studio Rentals #2, LLC, and Oasis Studio Rentals #3, LLC
5 ("Relief Defendants"), and their subsidiaries and affiliates (collectively
6 "Receivership Entities"), for Payment of Fees and Reimbursement of Expenses
7 ("Application") came on for hearing on August 20, 2018. Appearances were as
8 noted on the record.

9 The Court having received and read the Application, including any supporting
10 declarations and objections filed therein, and being so advised in the matter and
11 finding good cause, orders as follows:

12 **IT IS ORDERED** that the Receiver's Application is granted.

13 **IT IS FURTHER ORDERED** that the Receiver's fees and costs for the
14 Fourteenth Application Period are allowed and approved, on an interim basis, in the
15 amounts of \$200,878 and \$14,925.82, respectively.

16 **IT IS FURTHER ORDERED** that the Receiver is authorized and directed to
17 pay himself \$160,702.40 in fees and \$14,925.82 in costs from assets of the
18 receivership estate, which amounts reflect an interim payment of 80% of the
19 allowed fees and 100% of the allowed costs.
