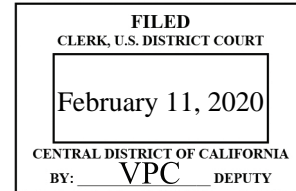

1 The Court having reviewed the Twentieth Interim Fee Application
2 ("Application") of Allen Matkins Leck Gamble Mallory & Natsis LLP ("Allen
3 Matkins"), general counsel to William Hoffman ("Receiver"), Court-appointed
4 permanent receiver for Defendant Nationwide Automated Systems, Inc. ("NASI"),
5 Relief Defendants Oasis Studio Rentals, LLC, Oasis Studio Rentals #2, LLC, and
6 Oasis Studio Rentals #3, LLC ("Relief Defendants"), and their subsidiaries and
7 affiliates (collectively "Receivership Entities"), including any supporting
8 declarations and objections filed therein, and being so advised in the matter and
9 finding good cause, orders as follows:


10 **IT IS ORDERED** that the Application of Allen Matkins is granted.

11 **IT IS FURTHER ORDERED** that Allen Matkins' fees and costs for the
12 Twentieth Application Period are allowed and approved, on an interim basis, in the
13 amounts of \$20,719.80 and \$1,568.40, respectively.

14 **IT IS FURTHER ORDERED** that the Receiver is authorized and directed to
15 pay Allen Matkins \$16,575.84 in fees and \$1,568.40 in costs from assets of the
16 receivership estate, which amounts reflect an interim payment of 80% of the
17 allowed fees and 100% of the allowed costs.
