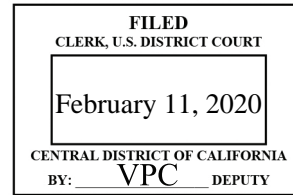


1 The Court having reviewed the Fifth Interim Fee Application ("Application")
2 of Duffy Kruspodin LLP, Certified Public Accountant to William Hoffman
3 ("Receiver"), the Court-appointed permanent receiver for Defendant Nationwide
4 Automated Systems, Inc. ("NASI"), Relief Defendants Oasis Studio Rentals, LLC,
5 Oasis Studio Rentals #2, LLC, and Oasis Studio Rentals #3, LLC ("Relief
6 Defendants"), and their subsidiaries and affiliates (collectively "Receivership
7 Entities"), including any supporting declarations and objections filed therein, and
8 being so advised in the matter and finding good cause, orders as follows:

9 **IT IS ORDERED** that Duffy Kruspodin LLP's Application is granted.

10 **IT IS FURTHER ORDERED** that Duffy Kruspodin LLP's fees for the Fifth
11 Application Period are allowed and approved, on an interim basis, in the amount of
12 \$13,844.83.

13 **IT IS FURTHER ORDERED** that the Receiver is authorized and directed to
14 pay Duffy Kruspodin LLP \$11,075.87 in fees from assets of the receivership estate,
15 which amounts reflect an interim payment of 80% of the allowed fees.
