The Court having considered the Motion for Discharge of Receiver and Appointment of Successor Receiver ("Motion") of William J. Hoffman of Trigild, Inc. ("Receiver"), the Court-appointed permanent receiver for Nationwide Automated Systems, Inc., Oasis Studio Rentals, LLC, Oasis Studio Rentals #2, LLC, Oasis Studio Rentals #3, LLC, and their subsidiaries and affiliates ("Receivership Entities"), and good cause appearing therefor, hereby orders as follows:

- 1. The Motion is granted.
- 2. William J. Hoffman is discharged of all duties and responsibilities as receiver in this action. Pursuant to the discharge, Mr. Hoffman is released from any and all claims and liabilities associated with the receivership, the Receivership Entities, and the individual defendants named in this action.
- 3. All actions taken by Mr. Hoffman in preserving, managing, and administering the receivership estate were consistent with the powers and duties assigned to the receiver under the Court's Orders; accordingly, all actions taken by Mr. Hoffman in performing his Court-ordered duties are approved and ratified.
- 4. Mr. Hoffman is hereby discharged from all further duties and responsibilities relating to the receivership without any further liability or obligation or responsibility for payment of liabilities of the Receivership Entities, Mr. Hoffman being entitled to those immunities and liability protections traditionally accorded to court-appointed receivers who have acted within the scope of the Court's delegated authorities.
- 5. Aaron J. Kudla is appointed permanent receiver for the Receivership Entities, with all duties, authorities, and responsibilities of the receiver as provided in the Court's Preliminary Injunction and Orders (1) Freezing Assets; (2) Prohibiting the Destruction of Documents; (3) Requiring Accountings; and (4) Appointing a Receiver (Dkt. 42) and subsequent Orders of the Court pertaining to the receivership
