The Court having reviewed the Twenty-Second Interim Fee Application (Dkt. 409 [hereinafter “Application”]) of Receiver Aaron J. Kudla (“Receiver”), the Court-appointed permanent receiver for Defendant Nationwide Automated Systems, Inc.


1 (“NASI”), Relief Defendants Oasis Studio Rentals, LLC, Oasis Studio Rentals #2, LLC,  
2 and Oasis Studio Rentals #3, LLC (“Relief Defendants”), and their subsidiaries and  
3 affiliates (collectively “Receivership Entities”), including any supporting declarations  
4 and objections filed therein, and being so advised in the matter and finding good cause,  
5 orders as follows:

6  
7 **IT IS ORDERED** that the Receiver’s Application is granted.

8  
9 **IT IS FURTHER ORDERED** that the Receiver’s fees and costs for the Twenty-  
10 Second Application Period are allowed and approved, on an interim basis, in the amounts  
11 of \$50,440.00 and \$4,074.63, respectively.

12  
13 **IT IS FURTHER ORDERED** that the Receiver is authorized and directed to pay  
14 himself \$40,352.00 in fees and \$4,074.63 in costs from assets of the receivership estate,  
15 which amounts reflect an interim payment of 80% of the allowed fees and 100% of the  
16 allowed costs.
