1 The Court having reviewed the Final Fee Application (Dkt. 423 [hereinafter
2 “Application”]) of Duffy Kruspodin LLP, Certified Public Accountant to the Court-
3 appointed permanent receiver (“Receiver”) for Defendant Nationwide Automated
4 Systems, Inc. (“NASI”), Relief Defendants Oasis Studio Rentals, LLC, Oasis Studio
5 Rentals #2, LLC, and Oasis Studio Rentals #3, LLC (“Relief Defendants”), and their
6 subsidiaries and affiliates (collectively “Receivership Entities”), including any supporting
7 declarations and objections filed therein, and being so advised in the matter and finding
8 good cause, orders as follows:

10 Duffy Kruspodin’s Application is **GRANTED**.

11
12 **IT IS FURTHER ORDERED** that Duffy Kruspodin’s fees and costs for the
13 September 17, 2019 through September 30, 2020 period are allowed and approved, on
14 final a basis, in the amount of \$13,982.40;

15
16 **IT IS FURTHER ORDERED** that Duffy Kruspodin’s five interim fee
17 applications and of the \$65,974.71 previously paid in connection with those applications
18 are approved on a final basis;

20 **IT IS FURTHER ORDERED** that the fees held back from Duffy Kruspodin's
21 five interim fee applications in the total amount of \$16,493.67 is approved; and


